



Diamond Club Rules

- 1) Diamond Club membership is subject to the terms and conditions established periodically by Del Mar Thoroughbred Club/Surfside Race Place (DMTC/SR).
- 2) Members must be eighteen (18) years of age or older. Valid photo identification is required for participation in Diamond Club and may be required upon use of this card and its rewards.
- 3) Limit one membership card per person.
- 4) Employees of DMTC/SR, any of its affiliated organizations or its vendors, including mutuel tellers, are not eligible for Diamond Club membership, special offers, promotions and special events.
- 5) There is no enrollment fee to become a Diamond Club member.
- 6) Diamond Club members earn wagering credit for all California Thoroughbred and Fair race meets at Surfside. Saddle Club members exclusively receive credit for all races, including imports. (Only CA Thoroughbred & Fair race meets are included in cash back rewards)
- 7) To avoid missing out on wagering credit, make sure your card is always working and registering in the machines. If your card is not working properly, the Gift Shop will issue you a new card. It is the players' responsibility to properly use the card.
- 8) Wagering credit adjustments will not be made for improperly inserted cards, using a previously issued card, cards that do not read for any reason including worn cards or any other type of error.
- 9) Wagering credit will not be earned when it is determined that a wager(s) is contributing to minus pools. When a single or multiple wagers placed by an individual(s) in the amount of \$10,000 or greater creates or is wagered into a minus pool, these wagers will not be eligible for the accumulation of wagering credit. As per California Horse Racing Board regulations, all pools must pay a minimum of 5% on each dollar. A minus pool is created when there are not enough funds to cover the minimum 5% payout on all winning tickets.

10) Each month is considered a unique monthly cycle for monthly wagering level rewards. Wagering credit begins on the first race day of the month and continues through the last race day of the month. Yearly wagering level rewards accumulate during the specified time period stated during the Surfside season. Rewards can be picked up at the Surfside Gift Shop after the 5th race day of the subsequent month. Cash back rewards are mailed.

11) Membership benefits and rewards are non-transferable, non-refundable and may not be brokered, bartered, or sold.

12) Use of the Diamond Club card by those other than the owner may result in immediate confiscation and cancellation. Members must surrender Diamond Club Cards upon request.

13) DMTC/SR reserves the right to exclude anyone from participation in the Diamond Club program.

14) All decisions by DMTC/SR management are final.

15) Diamond Club offers are subject to change without notice.

16) Rules of specific promotions vary (see the Gift Shop for specific promotional details).

17) Lost or stolen cards should be reported to the Gift Shop immediately. DMTC/SR reserves the right to charge a replacement fee for lost, stolen or mutilated cards.

18) Del Mar Thoroughbred Club/Surfside Race Place are not responsible for funds charged to accounts as a result of unauthorized use of the card and/or password code.

19) The Diamond Club is not a reporting agent of any kind. It is free and voluntary rewards program that does not track member wins and losses for this program and is not a complete or accurate account of your wagering activity.

20) Management reserves the right to adjust any account balance resulting from malfunction, operational errors, and/or fraud. Diamond Club account holders are subject to all applicable state and federal tax requirements. When applicable, Federal Income Taxes will be automatically withheld from wagers placed through the Diamond Club Card.

21) DMTC/SR reserves the right to terminate, revise or withdraw the Diamond Club program at any time without prior notice.
